The IBMC/i3S opens a tender procedure for the selection of 1 **Research Technician** within the Twinning project with the reference 952334 and the title "PhasAGE – Excellence Hub on Phase Transitions in Aging and Age-related Disorders" at IBMC, financed by H2020-EU.4.b.

Project summary and / or the tasks to be developed:

- Routine recombinant protein expression and purification.
- Establishment of protocols for analysis of protein phase separation in vitro.
- Organization and management of day-to-day lab activities.
- Participation in PhasAGE project outreach activities, including activities with high-school students.

Contractual terms: Working contract under the Portuguese Labour Law and the monthly remuneration of €1.636,62. Expect starting date: 1st November 2023, expected duration of 2 months.

Specific criteria for admission and general requirements:

- Familiarity with required techniques.
- Familiarity with the day-to-day functioning of a research lab in an academic environment.
- Must be fluent in both written and spoken Portuguese and English.

Evaluation criteria for selection:

- Detailed CV (90%) Scientific background and experience in relevant lab techniques (50%), previous work experience in research projects (20%) and relevant professional publications (including oral and poster presentations) (20%).
- Motivation letter (10%), describing interest and motivation for the area of research advertised.
